

We are proud to introduce this issue of *Wishmaker* as a testament to that endeavor right here in our Northeast New York chapter.

And we are also proud to designate 2019 as *The Year of the Wish Granter*, recognizing the frontline volunteers who are the face of Make-A-Wish. (See pages 4-5 for more.)

Among the remarkable wishes we were proud to grant during the last six months, this issue highlights: Ben's milestone wish; Alyssa, a Wish teen who gave back, and Brayden, who wished to meet his Yankees. All of these wishes, and more, were made possible thanks to the creativity of our Wish Granters, the dedication of our Mission Delivery Team, and the generosity of our donors.

We also continued to enjoy remarkable fundraising accomplishments. Our Fifth Annual Walk for Wishes in August broke records again this year, raising \$125,000 and engaging more than 600 participants. It was a wonderful community celebration of our great mission. We were also blessed to have more than 12 community fundraisers take place throughout the summer, raising \$395,000 to help make wishes come true for local children who are critically ill. This summer, we introduced our Wishing Space Project to a group of donors as our formal launch of this initiative to re-purpose our office space as a location for Wish Kids and their families to talk about wish possibilities with their wish granters.

Another exciting dimension of the summer was our bringing on three new members of our professional team: Scott Liloia as senior manager of wish granting; Mark McGuire as director of marketing & communications, and Raymond Gawlak as manager of volunteer engagement. Additionally, four new Trustees were elected to the Board: Kyle Kinowski, senior vice president & region head at The Ayco Company; Robert Roemer, vice president of project management at CAP COM Federal Credit Union; Leah Slocum, president of PEAK Partners Team Realty, and Lauren Weintraub, M.D., pediatric oncologist at the Children's Hospital at Albany Medical Center. The Board of Trustees voted in a new leadership team — Sarah A. McKinney as Board chair; Lisa M. Clifford as vice chair; David A. Druzynski as Board Secretary, and Michael P. Lasch as Board treasurer. The Board congratulated Brian V. Hannafin and Steven Kuring for their exemplary service as Board chair and Board secretary, respectively.

As this issue of *Wishmaker* goes to press, our planning for the 26th Annual Adopt-A-Wish Holiday Campaign is gaining momentum for the launch of the six-week fundraiser on Nov. 15. 

The Year of the Wish Granter

These trained volunteers are often the critical player in turning a child's wish into a reality. They are the ones who enter families' homes and work with children and their parents, divining answers to a question that can prove elusive: What do you really want?

"They," Make-A-Wish Northeast New York Chief Executive Officer William C. Trigg, III, said, "are the face of Make-A-Wish."

They are Wish Granters, the men and women who act as liaisons between Wish families and the Make-A-Wish staff, helping craft a child's special wish down to the finest detail. Their gathering of information and input are crucial to the child's wish journey.

That is why Make-A-Wish Northeast New York has designated 2019 as *The Year of the Wish Granter*, recognizing the vital service these volunteers perform. The Wish Granter will be the focus of the 2019 Make-A-Wish Gala on March 23 at the Hall of Springs in Saratoga Springs.

"They are the mortar that holds the edifice that is Make-A-Wish together." Trigg said. "Simply, it takes a Wish Granter for a child's wish to be realized."

Sandi Worona, a retired elementary special education teacher from Slingerlands, has been a Wish Granter for more than a dozen children. She has also been a Wish Mom for one — her daughter Adena, who 11 years ago battled a rare form of cancer as a 15-year-old. "I've seen both ends of it," Worona said. "It's a remarkable thing."

Worona's daughter chose to go on a family vacation for her wish. That teen is now 26, a social worker working with kids herself.

"Make-A-Wish is often thought about as kids getting a last dying wish. I love to correct that," Worona said. "Make-A-Wish provides a life-changing experience for them."

Mark Mortensen, a stock car driver at Fonda Speedway, presents donations to Make-A-Wish Wish Granter Lori DeBrino at Jumpin' Jack's in Scotia. And the Wish Granter's role in that experience?

"We are to guide the parents and make them feel comfortable through the process," Worona said. "We are there to just listen and hear what the children want to do.

"Our role is to be a good listener, be honest ... and leave them with a smile on their face."

They are the original Wish Granters. After being told by his wife Kay Austin in 1980 about a critically ill boy's desire "to catch bad guys," U.S. Customs Agent Tommy Austin embarked on a quest to make 7-year-old Chris Greicius' wish a reality.

That effort gave root to the organization that became known as Make-A-Wish. The Austins, considered the original Wish Granters, will be special guests at the Annual Make-A-Wish

Northeast New York Gala March 23 at the Hall of Springs in Saratoga Springs. The choice could not be more appropriate: Make-A-Wish Northeast New York has designated 2019 *The Year of the Wish Granter*. After hearing about Chris, Tommy

Austin told Arizona Department of Public Safety Officer Ron Cox during a stakeout about the young boy who was losing his battle with leukemia, but wanted to be a police officer. Through a mushrooming effort of multiple officers, Chris became Arizona's first and only honorary DPS officer.

The officers won a race against time. Chris died less than a week later. "He was only seven years, 269 days old when he died. But he taught me about being a man," said Tommy Austin, a Make-A-Wish co-founder. "I can tell you that because of meeting Chris, I am an entirely different man. Ron Cox said the same thing. He said he didn't fear death anymore, because he knew Chris would be there waiting for him."

A night of elegance, from décor to cuisine, will mark the 2019 Gala, a blacktie evening of fine food, great music and inspiring stories.

"We look forward to celebrating the Make-A-Wish Northeast New York Annual Gala with our donors, thanking them for all they do in making wishes come true," CEO William C. Trigg, III, said.

The 2019 event will focus on the mission of the local organization, with Wish kids and families in attendance to share their stories. And the Austins will represent our Wish Granters, the volunteers vital to turning wishes into actual experiences.

In addition to great food and live music, both silent and live auctions will be featured, with a variety of offerings that will appeal to everyone. Those who are unable to attend in person can still bid via smartphone or online, to ensure they can be part of the fun, while supporting Make-A-Wish Northeast New York.

A Wish Takes Of

Southwest Airlines helped a Mohonasen High School student's wish truly take flight.

Before taking off for Orlando, Florida, and Disney World in July, 15-year-old Ben got the full tour of Southwest's operation. Pilots showed him around the cockpit and explained the controls, while the ground crew even let him take a turn at guiding an aircraft to its gate from the tarmac. "[Southwest] is a really good company," said

Benjamin, who has a life-threatening form of epilepsy.

The wish, facilitated by Wish Granters Linda and Michael Doyle, was the milestone 1,800th for Make-A-Wish Northeast New York since the establishment of the chapter in 1987.

According to Ben's mother, Carrie, the trip changed her son's outlook. The entire time Ben was on his wish, he was laughing, smiling and laid back.

"We have a lot of medical issues and he wasn't thinking about them," Carrie said. "He wasn't worried all the time. It was just a care-free experience, not worrying about anything except the next place we were going to have fun."

Make-A-Wish Northeast New York Chief Executive Officer William C. Trigg, III, noted about 80 percent of the chapter's wish kids reach adulthood.

"We've known about the medical impact of a wish and now we have proof to be able to show that's the case," Trigg said. "We now have empirical evidence to prove the medical benefits. The wish is really part of the medicine."

Disney - his actual wish - lived up to his hopes.

"We went to every park," Ben said, "Sea World, Universal, Hollywood Studios. It was so much fun." The 15-year-old also sees himself going to flight school one day. He hopes to fly for Southwest.

Milestone Wishes

Miles were logged and records fell in an August Walk For Wishes[®] event in and around Joseph L. Bruno Stadium that singlehandedly raised enough in donations to fully fund more than 10 wishes.

Wish kids and alumni, family and supporters turned out in numbers never seen before to drive the historic Walk at The Joe on the campus of Hudson Valley Community College. The event raised more than \$125,000 — not only a record, but a 33 percent jump from 2017 and a total that far exceeded the Make-A-Wish Northeast New York goal of \$115,000.

In 2017, the Walk For Wishes raised \$94,000 — blowing past the goal for that year of \$75,000.

"We are so excited about the results of the 2018 Walk for Wishes!" said Kirsten Broschinsky, director of Annual Giving for



Make-A-Wish Northeast New York. "The success of this event is based completely on the incredible hard work and dedication of those whose lives have been touched by a wish and have come together to make sure wishes keep happening.

"Today, we've seen parents, grandparents, kids, neighbors, friends, and even strangers who have just heard the stories and been touched all work together, dollar by dollar, step by step, to make wishes come true!"

More than 600 participants were spread out over 47 teams, the largest ever, aided by nearly 60 volunteers.

In September, the baseball team that calls The Joe home, the Tri-City ValleyCats, won its third New York-Penn League title. But on a Saturday in August, the ballpark hosted hundreds who can also call themselves champions.













I Wish To Give Back ...

Alyssa, and the Gift of Giving

North Country teen's wish is to donate funds to adult day center

Alyssa, a Make-A-Wish teen from Lewis, worked with her Wish Granters, Pat MacMannis and Amy Patnaude, and family for a year to decide what she wanted to do with her wish.

"I was struggling to come up with what I wanted for a wish and I was just talking to Mom about it and we were just thinking of things we could do," Alyssa explained.

"And then I kind of just thought of it."

The best gift, she decided, is to give back.

So the 16-year-old, who has spent her life dealing with Nephrotic syndrome, a kidney disease, fulfilled her Make-A-Wish dream in August by donating \$8,000 to benefit the Third Age Adult Day Center in Plattsburgh, where she volunteers and her mother, Jessica, works.

"We started out with, 'I want to go on a trip,' and then she decided that's not what she wanted," the mom said. "Then she decided she wanted a dog. And then she decided, 'No that's not what I want.'



"So we took a few months off and finally she goes, 'I know what I want, and if I can't have it there's nothing else I want.' So she told me that she would like to give back to the Third Age Adult Day Center."

Alyssa, overwhelmed by the wide attention garnered by her check presentation at SUNY Plattsburgh's Sibley Hall, stated she was thrilled to help friends. Clinton-Franklin-Essex Counties Lead Wish Granter MacMannis, who has been working with Make-A-Wish for 27 years, said Alyssa's choice did not surprise.

"She's very observant and she has a huge heart. And I think she sees a lot of herself in some of these participants in the program," MacMannis said. "I

think she sees people that need to ask for help sometimes and sometimes are vulnerable and I think she is someone who has had their own challenges with their health, recognized that in them and it's a chance for her to give back."

The Third Age Adult Day Center is a program for elderly individuals with developmental disabilities and memory impairment. Program Manager Christine Ouellette says the money Alyssa is giving through Make-A-Wish will allow for the construction of a safe inner courtyard and patio area.

A Wish Knocked Out of the Park

The Queensbury 9-year-old's wish to meet members of his favorite team, the New York Yankees, was fulfilled and then some, thanks to Wish Granters Nancy Blair and Scott Liloia.

Brayden's favorite part: Going to Yankee Stadium and meeting slugger Aaron Judge, who gave him an autographed bat. He also met several other players and manager Aaron Boone, many of whom signed his bat and shirt. Several players wore his wristband during the game that day.

He toured the clubhouse, which was nicer than he expected, and Monument Park, got to try on a Derek Jeter and Judge jersey and even hold a Babe Ruth bat.

But there was more.

Brayden, who has a brain tumor,

took a limo to New York from Albany Medical Center, where doctors and nurses gave him a hero's sendoff. He tackled Manhattan, where he saw his first Broadway show, "Wicked." He took in the sights and stores, and particularly enjoyed that when he asked for a souvenir or something else, mom said "yes."

The fundraiser has a tagline that serves as a warning, and a lure: *This ain't no bake sale* ...

Make-A-Wish Northeast New York Wish Granter Mary Kenney hit on the idea in 2011 of deploying skydiving as a means to raise money for the chapter.

"I wanted to do something fun. I wanted to do something unique," she said. "The first time I did it, I thought it would be a one-time thing."

There she was wrong. Things continue to look up for the Wish Jump, which has become a key fundraiser unique to the Northeast chapter.

"It just keeps growing," Kenney said.

This year's Wish Jump featured former Wish kids and teens and parents, CEO William Trigg, III, and other donors, and raised a whopping \$38,699.

Since 2011, nearly 100 Wish Jumpers have participated, and raised more than \$250,000.

A Rolling Roar of Hope

That sound you heard in the North Country in late July was the rumble of bikers riding to benefit critically ill children.

Have you ever denied a wish due to lack of funding?

NO! We are committed to granting the wish of every eligible child. Because we do not ever turn down an eligible child, we must maintain our revenues to fund all of these wishes. That is why it is critical that we raise important funds throughout the year through a variety of means. Inkind donations of goods and services allow us to make every dollar donated for wish granting purposes go farther.

Can we pay for a particular wish?
