THE FOUNDATION GRANTED 34 WISHES, SERVING 131 PEOPLE, DURING THE FISCAL YEAR ENDED AUGUST 31, 2020. THE TOTAL COST OF WISHES GRANTED FOR THE FISCAL YEAR WAS \$404,931. OF THIS AMOUNT, \$155,489 WAS CONTRIBUTED BY VARIOUS VENDERS WHO PROVIDED IN-KIND CONTRIBUTIONS SUCH AS TRAVEL AND TRAVEL SERVICES, TRANSPORTATION, LODGING, AND OTHER SERVICES AND USE OF FACILITIES TO COMPLETE A CHILD'S WISH.
