IN 2019, WE GRANTED 190 WISHES FOR CHILDREN WITHIN OUR TERRITORY - ARKANSAS, NORTH MISSISSIPPI AND WEST TENNESSEE. THESE WISHES IMPACTED OVER 1,000 PEOPLE DIRECTLY IN OUR PRIMARY PROGRAM - THE WISH CHILD, THEIR FAMILY, THE WISH GRANTING VOLUNTEERS, AND THE WISH SPONSORS WHO PARTICIPATED IN THE UNVEILING OF THE WISH.
