THE FOUNDATION GRANTED A TOTAL OF 58 WISHES TO CHILDREN DURING THE FISCAL YEAR ENDING AUGUST 31, 2020. THE TOTAL COST OF WISHES GRANTED FOR THE FISCAL YEAR WAS \$658,736. OF THIS AMOUNT, \$54,197 WAS CONTRIBUTED BY VARIOUS VENDORS WHO PROVIDED IN-KIND CONTRIBUTIONS SUCH AS TRAVEL AND TRAVEL SERVICES, TRANSPORTATION, LODGING, AND OTHER SERVICES AND USE OF FACILITIES TO COMPLETE A CHILD'S WISH. FOR FINANCIAL STATEMENT PURPOSES, THESE AMOUNTS ARE INCLUDED AS CONTRIBUTION REVENUE AND GRANTED WISH EXPENSE.
