THE FOUNDATION GRANTED A TOTAL OF 29 WISHES TO CHILDREN DURING THE FISCAL YEAR ENDING AUGUST 31, 2021. THE TOTAL COST OF WISHES GRANTED FOR THE FISCAL YEAR WAS \$294,952.
