Makinley's Wish: Kindling Joy

Makinley's wish for a firehouse playhouse was inspired by her father, Joseph Jarvey Jr., who is a firefighter in Peabody, MA. One of Makinley's favorite things to do is visit him at the station. "No matter how many times Makinley goes there, she's always as excited as if it were her first time," says her mom, Adriana Gallant. "There isn't a firetruck in Peabody that she hasn't been on," adds Joseph.

Makinley was hospitalized for the first 11 ½ months of her life due to chronic respiratory failure before she was able to be at home. Her visits to the fire department began when she was just a year old and they weren't simple, as she was on oxygen and had a tracheostomy. The Peabody Fire Department rallied around Makinley and her family and has been very supportive of them throughout her health journey.

Makinley spends a lot of time with nurses and trained adults, and her wish provides her with a space where she can be a carefree child, and where the adults in her life can also play with her.

Bertolino Foods of Peabody, MA, sponsored Makinley's wish and Lilliput Play Homes in Pennsylvania custom built her firehouse playhouse. Allie Kenawell, Director of Sales for Lilliput, says, "It's such a privilege for our company to design and build private spaces that promote imaginative play for children and their families. Our Lilliput Play Homes team is so grateful to be able to contribute to the joy that children like Makinley experience through Make-A-Wish."

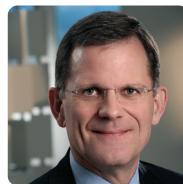

For 27 years, the Cottage Park Yacht Club (CPYC) in Winthrop, MA, has been supporting our wish children. In 1995, a group of members established a regatta to benefit what was then the Make-A-Wish Foundation of Greater Boston. That event raised enough to grant three wishes and cemented its place as an annual event on CPYC's calendar.

Geraldine Cross of Russell, MA, was introduced to Make-A-Wish Massachusetts and Rhode Island by longtime Make-A-Wish supporter Dr. Phil Glynn, who serves on our Board of Directors. Geraldine has sponsored our Swish Night event in Western Massachusetts for many years, including as Presenting Sponsor for the past two through her company, GTB Innovative Solutions in Westfield, MA.

A dynamic businesswoman, Geraldine designed a program to help single mothers on welfare secure a used car. She successfully advocated for state funding for the program and engaged credit unions to provide grants to applicants, while herself helping applicants secure car insurance and teaching them car maintenance. Geraldine also innovated a more efficient way for the federal government to sell vehicle fleets and currently manages those sales for 28 federal agencies.

"I grew up without a lot and have been fortunate with success and blessings. Having been given a lot, I need to share it," she reflects. Geraldine's generous involvement with our organization is expanding this year as she joins our newly-formed Western and Central Massachusetts Advisory Council.

"The opportunity to provide wish children with something to look forward to and provide them with a sense of well-being is very rewarding," says Geraldine. "It's reciprocal joy."
