40 years and counting! Our Chapter all started with Dr. Jim Manion and his wife Pat in 1983. They responded to an ad in the Los Angeles Times seeking interested individuals willing to start a Make-A-Wish Chapter in their state.

Thanks to their vision, Make-A-Wish Nebraska was formed in 1983 with the very first wish granted for wish kid Brenda, who wished to go to Walt Disney World®. Forty years later, our Nebraska Chapter has grown to 3 offices -- one in Omaha, one in Lincoln and one in Kearney, and there are over 350 volunteers throughout the sate that have helped grant 3,100+ wishes.

Children who are currently waiting for their wish have had to endure more than most people endure in a lifetime. For these children, feelings of isolation and hopelessness are all too familiar. Hospital stays, doctor's visits and painful treatments are their "new normal." Family plans are put on hold indefinitely. Uncertainty looms, constantly.

Wishes aren't just "nice to have," they are a necessity. For many children, a wish marks a significant turning point in their medical journey. The hope of a wish come true is more than a temporary escape, it is a wellspring of strength to keep fighting for better days.

Because of YOU, we were able to grant the heartfelt wishes of 116 children this past fiscal year. Because of YOU, a wish child has been able to envision a brighter future through a wish. Because of YOU, local wish kids and their families will have lasting memories for vears to come.



Harlan's Story

Heart defects happen in 1 in 100 babies. We found out at our 20-week ultrasound that our 3rd child would have severe congenital heart disease. Harlan was born with half a heart, and his defects are 1 in 200.000 for how unique his heart is.

Our world was turned upside down knowing three open heart surgeries were the only known means of survival. Harlan's first open-heart surgery was at 2 days old and his second at 5 months old. His heart continues to be monitored and a third surgery is in his future. I had to become his full-time nurse, and NG tube fed him the first 6 months of his life. Having a 4-year-old and 2-year-old at home at the same time, seemed unreal that keeping it all together would be possible, but I've learned on this journey that you don't know how strong you are until being strong is the only choice you have.


There is no cure, only monitoring, procedures and surgeries. This disease is lifelong. Harlan was, and is a fighter and showed us with his amazing resilience that

he would defy the odds and be a warrior. On the outside not knowing Harlan, you'd never know he fights this battle every day, but if you ask him where his heart is he'll show you and tell you ...the strongest hearts have the most scars.

He is your typical boy who loves the outdoors, playing in the mud, riding bikes, fishing and keeping up with his older brothers. Harlan's love of climbing, the outdoors & trees at an early age drew him to wanting a treehouse from the time he could talk. Receiving this wish to have a treehouse means he can go into his backyard every day and have a place to escape, play and just be a kid, away from doctor appointments and medications he takes daily, to be free and let his imagination run wild.

This wish lets us see, feel and experience the hope we all want for kids like Harlan who battle childhood diseases daily. This wish has been a once-in-a-lifetime experience for all that Harlan and our family has been and will continue to address in the years ahead. We are honored for this amazing treehouse and the years of adventure that await Harlan in his own backyard.

Truly, we are forever grateful.





# Our future, Our challenges, Our Needs...

Our vision is to provide a wish for every eligible child in Nebraska.

In March 2020, Make-A-Wish made the difficult decision to pause granting wishes involving travel in order to protect the safety and health of our wish kids and their families. However, we never stopped granting wishes during that time. We continued to grant many nontravel wishes. Some children changed their initial travel wish to something they could enjoy right way. But many children waited 2 years, until travel restrictions were lifted, to experience their heartfelt wish to travel.

Due to the delays caused by COVID19, Make-A-Wish Nebraska now has more wishes waiting to be granted than ever before. Currently, we have over 180 wishes – our largest number ever – waiting for their wish. We anticipate this larger than normal number of kids waiting for their wish to come true to be elevated for the next 2 ½ to 3 years. In order for us to fulfill our vision of granting the wish of every eligible child, we must raise crucial funds and build the capacity to grant all the wishes of critically ill children when they are able and ready to go over the next several years.
