

The mission of Make-A-Wish Greater Pennsylvania and West Virginia is to create life-changing
wishes for children with critical illnesses. In fiscal year 2023, Make-A-Wish continued
with a moratorium on all international travel and cruise wishes which typically
account for about 40 wishes a year. The chapter continues to recover from wish stoppages
that were in place during the pandemic, but was able to grant 521 wishes in the fiscal year
ending August 31, 2023. Wishes included 70 gift wishes, 53 shopping sprees, 260 trips
to Walt Disney World, 20 play sets or playhouses and 3 swimming pools. Unique wishes
include Allison's wish for a Hello Kitty-themed golf cart, Josiah's wish to visit Denali
National Park, Brier's wish to visit the Nike headquarters, Anna's wish for a gazebo,
Ethan's wish to be a zoologist and Emma's wish for a manual sewing machine.

Pt III, Line 3: In December 2019, an outbreak of a novel strain of coronavirus (COVID-19) began. On March 10, 2020, in conjunction with the Make-A-Wish America National Medical Advisory Council, Make-A-Wish America issued instructions to pause travel and large gathering wishes until deemed medically safe for our vulnerable population and their families. On March 11, 2020, the World Health Organization characterized COVID-19 as a pandemic.

Other: As of September 15, 2021, in consultation with the Make-A-Wish National Medical Advisory Council, the pause on domestic travel to large gatherings was lifted, if travel occurred by automobile. The pause on airline travel was lifted December 1, 2021, with a graduated approach with full domestic travel resuming June of 2023. International and cruise wish travel is still paused as of August 31, 2023. Prior to fiscal year 2020, travel wishes have been approximately 75% of wishes granted and the number of granted wishes averaged approximately 537.

The number of wishes granted during the years ended August 31, 2023, and 2022 were 521 and 392, respectively. The Foundation continues to evaluate all expenses and fundraising efforts in light of the impact of COVID-19.

Pt III, Line 3: The Foundation's Pittsburgh office closed and transitioned the staff to work from home as of May 19, 2021, due to a fire. The office was unable to be occupied until November 1, 2021. Temporary internal control policies were implemented to accommodate this closure.

Pt VI, Line 11b: Form 990 is prepared by an independent CPA and reviewed by the CFO, the COO, the CEO and the Board Treasurer. The Draft is then sent to

Pt VI, Line 18: Under the second round of Paycheck Protection Program funding, the Foundation applied for and was approved for an additional \$568,095 loan.

The loan was received on February 8, 2021. The loan accrues interest at 1%, with the first ten months of interest deferred, has a term of five years and is unsecured and guaranteed by the Small Business Administration. The Foundation is eligible for loan forgiveness of up to 100% of the loan, upon meeting certain requirements. The Foundation received forgiveness of \$568,095 October 26, 2021.

The SBA may review funding eligibility and usage of funds for compliance with program requirements based on dollar thresholds and other factors. The amount of liability, if any, from potential noncompliance cannot be determined with certainty; however, management is of the opinion that any review will not have a material adverse impact on the Foundation's financial position.

Other: Grants from the government are recognized when all conditions of such grants are fulfilled or there is reasonable assurance they will be fulfilled.

During the year ended August 31, 2021, the Foundation applied for Employee Retention Credit (ERC) grant funding from the Internal Revenue Service. The Foundation recognized \$645,913 of grant revenue related to performance requirements being met in compliance with the program during the year ended August 31, 2022.

The Foundation has received all payments from the IRS. Eligibility and conditions for the ERC program may be audited by the IRS. The amount of liability, if any, from potential noncompliance cannot be determined with certainty; management

is of the opinion that any audit will not have a material adverse impact on the Foundation's financial position.

Other: The Foundation implemented lease accounting standard 842 for the fiscal year ended August 31, 2023. The Foundation determines if an arrangement is a lease at inception. The Foundation leases equipment and office facilities for various terms under long-term, non-cancelable lease agreements. The leases expire at various dates through 2031.

The Right-Of-Use (ROU) assets represent the Foundation's right to use an underlying asset for the lease term and lease liabilities represent the Foundation's obligation to make lease payments arising from the lease. ROU assets and liabilities are recognized at the lease commencement date based on the present value of lease payments over the lease term. The Foundation has elected to use a risk-free discount rate determined using a period comparable with that of the lease term for computing the present value of lease liabilities.

The ROU Asset and Lease Liability are shown in the other assets (Part X line 15) and other liabilities (Part X line 25) in the amount of \$1,513,834 and \$1,673,895, respectively.
