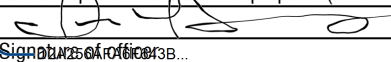

THE BYLAWS CLARIFIED THE AUTHORITY AND RESPONSIBILITIES OF THE CEO, INCLUDING:

- RESPONSIBILITY FOR HIRING, SUPERVISING, AND MANAGING STAFF;
